Description: I propose that we think of our shared concepts as having whatever application conditions they would need to have in order best to deliver benefits in the ways they have regularly delivered benefits in the past. This combines naturally with a philosophical methodology for discovering the correct application conditions of our shared concepts, the methodology that I call *Pragmatic Conceptual Analysis*. I articulate and defend this methodology, and show how it may fruitfully be applied to problems in philosophy of mind, philosophy of science, and metaphysics.
